THE PROGRAM OFFERS HELP FINDING AFFORDABLE HOUSING, NAVIGATING VA-HEALTHCARE, AND PROVIDES ACCESS TO LEGAL SERVICES FOR HOUSING-RELATED ISSUES. ALL SSVF SERVICES ARE AT NO COST TO THE VETERAN. 343 VETERANS WERE HELPED THROUGH THE SSVF PROGRAM IN 2023.

THE SERVICE CENTER ASSISTS VETERANS WITH PERSONAL IDENTIFICATION NEEDS, BENEFITS COUNSELING, LEGAL ISSUES, RELIABLE MAIL SERVICE, MILITARY RECORDS RETRIEVAL, TRANSPORTATION, CLOTHING, FOOD, PERSONAL CARE ITEMS, AND REFERRALS TO APPROPRIATE COMMUNITY AGENCIES.
